## TERMS AND CONDITIONS

The Buyer authorizes Synergy Seafood Trading, LLC.. to confer with the bank and listed references on page 1, along with other purveyors and creditors that may do business with the Buyer, for credit information.

The Buyer agrees to immediately notify Synergy Seafood Trading, LLC.. in writing, at our address on the reverse side, of any change in ownership or form of said business.

The Buyer agrees jointly and severally to pay for all seafood products, wares and merchandise supplied to the Buyers place of business, or where the Buyer is carrying on a business activity. The Buyer agrees to a service charge of 1 ½% per month of past due amounts. In the event it becomes necessary to place the account for collection, the Buyer agrees to pay all costs of collection, including attorney fees, filing fees, interest, court costs and any other applicable costs. The Buyer waives the right of trial by jury. All litigation to be in Orange County, Florida.

Anyone at the Buyers place of business, or where the Buyer is carrying on a business activity, who signs for, or accepts the receipt of goods from the Seller, at such place is presumed to be the agent of the Buyer, and therefore conclusively able to accept deliveries. The Sellers customary terms and conditions of sale govern all transactions between the Buyer and Seller. Special terms and conditions claimed by the Buyer must be authorized in writing by the Seller, through a person who has the authority to do the same. Sales and delivery personnel do not have such authority. The Seller reserves the right to decline to sell any customer, and assumes no liability for failure to deliver.

This agreement shall remain in full force until written notice of revocation is received by Synergy Seafood, Trading, LLC.

The individual signing this credit application, by such signing thereby personally guarantees the payment of the account of the Buyer according to the terms and conditions of this agreement and of all invoices which comprise the account. Faxed signatures to be legal and binding.
